

## **RESULTS** OF POSTAL BALLOT (INCLUDING EVOTING) ANNOUNCED ON 25<sup>TH</sup> MARCH 2015

Pursuant to Section 110 of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014, the board of directors of the company had accorded his approval to conduct a postal ballot to seek the consent of the members of the company for the proposed special resolution to be passed through postal ballot as specified in the notice dated 19<sup>th</sup> February 2015, read with the explanatory statement thereto.

The company has appointed Mrs. Rupal Pranav Patel, practicing company secretary as the scrutinizer for conducting the postal ballot process in a fair and transparent manner.

The voting period for e-voting commenced on 24<sup>th</sup> February, 2015 at (1100 a.m.) and ended on 25<sup>th</sup> February, 2015 (6.00 p.m.) and the CDSL e-voting platform was blocked thereafter and the votes cast under e-voting facility were then unblocked in the presence of two witnesses who were not in the employment of the Company. Votes cast through physical ballot forms received up to 23<sup>rd</sup> March, 2015 were considered.
